Under e-flux’s custodianship, the .ART gTLD will become a valuable and encyclopedic resource for anyone interested in art.

Octavio Zaya can vouch for and has worked closely with e-flux.

Octavio Zaya supports this application, and in doing so, understands that in the event that the application is successful, e-flux will be required to enter into a Registry Agreement with ICANN. In doing so, they will be required to pay fees to ICANN and comply with consensus policies developed through the ICANN multi-stakeholder policy processes.

This application is being submitted as a community-based application, and as such it is understood that the Registry Agreement will reflect the community restrictions proposed in the application. In the event that we believe the registry is not complying with these restrictions, possible avenues of recourse include the Registry Restrictions Dispute Resolution Procedure.
