This letter is to confirm that the **Association of Black Cardiologists** fully supports the application for .health submitted to ICANN by DotHealth, LLC in the New gTLD Program. As the **President**, I confirm that I have the authority of the **Association of Black Cardiologists** to be writing to you on this matter.

We have carefully reviewed how DotHealth, LLC intends to operate and manage the .health new gTLD registry, and we are highly supportive of the proposed policies and procedures that have been identified for the purposes of this application. In sharing a commitment to safety, information quality and trust, these policies and procedures are very consistent with the standards, policies and best practices that the **Association of Black Cardiologists** already supports and advocates to our membership and key stakeholders.

The **Association of Black Cardiologists** supports this application, and in doing so, understands that in the event that the application is successful, DotHealth, LLC will be required to enter into a Registry Agreement with ICANN and comply with consensus policies developed through the ICANN multi-stakeholder policy process.
