Subject: Supporting letter for the “.leclerc” gTLD evaluation process

This letter is to confirm that E.LECLERC VOYAGES fully supports the application for the “.leclerc” extension submitted to ICANN by ACDLec as part of the *New gTLD* initiative.

As the board director of E.LECLERC VOYAGES, I have full authority to take such a position.

E.LECLERC VOYAGES is one of the main entities contributing to the E. LECLERC Community with the applicant (ACDLec) along with the 556 French and 110 international hypermarkets, as well as the 16 local cooperatives.

E.Leclerc Voyages is the entity specialized in the Trade tourism and its members both at a national and an international level, and working closely with ACDLec to create and manage product brands.

The requested *New gTLD* will be used to provide the Community with a recognizable identifier and increase the visibility of the official communication. It will help unifying the corporate communication, fighting against phishing and decreasing the cybersquatting abuses. It will then provide a secure and safe Internet environment to the Community.

ACDLec will be the single registrant for domain names in “.leclerc” as it best represents the shared interests of the Community. It will then delegate the use of some domain names to the other entities of the Community and ensure that the related websites will stay in compliance with the fundamental values and principles of the E.LECLERC Community.

ACDLec intends to charge a fee for the registration of domain names under the “.leclerc” gTLD on a cost-recovery basis. It will assign the operation of the “.leclerc” gTLD to a team of minimum three people possessing administrative, marketing, legal and technical skills.

E.LECLERC VOYAGES has been working closely with the applicant in the development of this proposal.

E.LECLERC VOYAGES fully supports this application and acknowledges that, in the event the application is successful, ACDLec will be required to enter into a Registry Agreement with ICANN.

Since ACDLec is submitting a community-based application, it is understood that the Registry Agreement will reflect the community restrictions listed in the application. In the event the registry is not complying with these restrictions, possible avenues of recourse will include the Registry Restrictions Dispute Resolution Procedure.

Please be assured of my strong support to this application which is a great opportunity for the E. LECLERC Community to develop and control its brand on the Internet in a secured way.
