This grouping of endorsements contains regional, national and international organizations that represent a wide variety of service oriented nonprofit and non-governmental efforts created to support members of the Gay Community.

From very early in the gay rights movement, organizations like the ones represented here have stood at the front line of progress for the Gay Community creating real change where it was needed. Letter of Support from KANHNHA CAMBODIA to LGBT (dotgay)

Dear Dr. Crocker, Mr. Beckstrom and Members of the ICANN Board,

It is with great enthusiasm that we write this note in support of ICANN's consideration to create the proposed .gay top-level domain (TLD), under the proposed community model put forth by dotgay LLC.

KANHNHA was established in Cambodia as a non-profit, non-governmental organization in 2002 and officially registered with the Ministry of Interior in 2004. In recognition of its work, KANHNHA has successfully performed and implemented in the areas of HIV interventions. Since its foundation, KANHNHA has intervened HIV prevention in Phnom Penh and Kandal Province.

MSM/Transgender in Cambodia continues to face stigma and discrimination from communities and civil society in the private sector/civil societies who do not yet understand MSM/Transgender issue. These problems come from limited coverage and education in these areas. Funding to MSM/Transgender programs has decrease from year to year because of economic crisis. What KANHNHA aims to strengthen are community sustainability and empowerment.

There is no specific legislation that protects the rights of MSM from stigma and discrimination in their home or in the workplace. All Cambodians are assumed to be protected by the Constitution. In practice, however, MSM (particularly long hair/Transgender) report regularly that they suffer from discrimination in employment, schooling and in the community, regardless of their HIV status (HIV PREVENTION REPORT CARD CAMBODIA CONDUCTED BY RHAC).

KANHNHA is committed and respect that LGBT are Human Right. We wish to see all countries around the world push their efforts to raise LGBT rights to the status of human rights, especially those involved in policy making like the agencies in the United Nations. KANHNHA wish to see MSM/Transgender fair with right as general population no need to have special right.

KANHNHA wish to see dotgay LLC lead, help and support the environment of LGBT around the world and therefore support their efforts to create and manage the .gay domain. We wish dotgay LLC great success with this incredible opportunity for the LGBT in the world.


The Gay Group of Bahia ("Grupo Gay da Bahia") is the oldest association for the defense of the human rights for homosexuals functioning in Brazil. Founded in 1980, the GGB was registered as a non-profit organization in 1983, and was declared a public service organization of the city of Salvador in 1987. It is a member of the International Lesbian and Gay Association (ILGA), it forms part of the staff of the International Lesbian and Gay Human Rights Commission (IGLHRC), the National Association of Black and White Men Together, and it is a "twin" of the RFSL of Stockholm. Since 1989, it has been a member of the Health Ministry's National Commission to Control AIDS, and since 1995 it has been one of the coordinators of the Secretariat of Human Rights of the Brazilian Association of Gays, Lesbians and Transvestites (ABGLT).

The GGB was directly responsible for the foundation of several groups in defense of the human rights of homosexuals in other states of Brazil, and it provides a meeting space for the Lesbian Group of Bahia, the Association of Transvestites of Salvador, and the Anti-AIDS Center of Bahia, entities which are allied with yet independent from the GGB. In 1985, the GGB promoted the Third Encounter of the Brazilian Homosexual Movement and in 1994, the Sixth Encounter of Brazilian AIDS NGO's. The group publishes the GGB Bulletin two or three times a year, and has produced two dozen pamphlets and booklets about homosexuality and AIDS.

Any citizen can become a member of the GGB, independent of sex, sexual orientation, race and ethnicity, religion, or political ideology: the GGB presently has 500 regular members. Between 100 and 200 people visit the GGB's center every week, making the number of visitors during the group's 16 years of existence exceed 20,000. The following subgroups form part of the GGB: the Quimbanda-Dudu Group of Black Gays of Bahia; the Gay Stamp Association of Brazil; the Brazilian Association of Parents and Friends of Homosexuals; the Center for Homosexual Studies.






