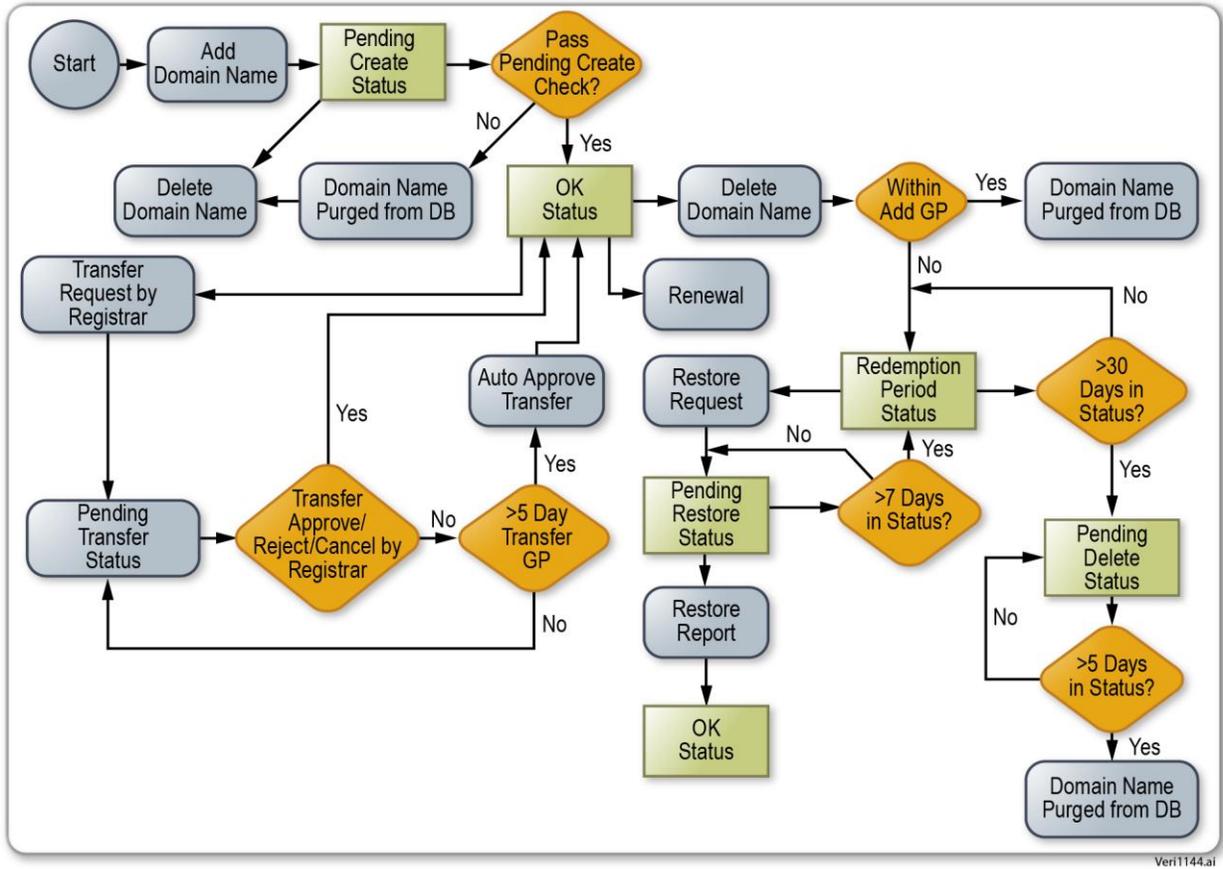


Figure 27-1: Registration Lifecycle State Diagram

Registration State	Registration State Description
Pending Create	Once the domain name is registered through the Add Domain operation, the domain name enters the Pending Create state and will not resolve in the DNS. The domain name can be immediately deleted through a Delete Domain operation. The registrant contact information is verified to ensure accuracy, and other security elements associated with the domain name are validated in the Pending Create Check decision. If the domain name passes the Pending Create Check, it enters the OK state; otherwise it is immediately deleted. The result of the Pending Create status includes a notice in the form of an EPP poll message as defined in Section 3.3 of RFC 5731, Domain Name Mapping. Upon a successful Pending Create Check decision, the two-factor authentication credential identifier to be bound or pre-bound to the domain name can be included in the Pending Create EPP poll message.
OK	Once the domain name is registered through the Add Domain operation and passes the Pending Create Check decision, the domain name enters OK state and the Add grace period (AGP) begins. The domain name can be renewed later through either Explicit Renew or Auto Renew operations to extend its expiration date.
Pending Transfer	The domain name enters the Pending Transfer state through the Transfer Request operation initiated by a non-sponsoring registrar that has the matching two-factor authentication information (OTP). The domain name remains in the Pending Transfer state for up to five days until one of the following operations occurs: Transfer Approve, Transfer Reject, Transfer Cancel, or Transfer Auto Approve. Once the operation is completed, the domain name goes back to OK state.
Redemption Period	The domain name enters the Redemption Period state through the Delete Domain operation, which the sponsoring registrar performs outside the five-day AGP with the matching two-factor authentication information. If it is deleted within five days of the AGP, the domain name is purged from the database and is immediately available for new registrations.
Pending Restore	The domain name goes to Pending Restore state if there is a Restore Request operation within 30 days of the Redemption grace period. The domain name goes back to OK state if there is a Restore Report operation within seven days of the Restore Request grace period. Else, the Pending Restore to Redemption Period batch moves the domain name back to Redemption Period state.
Pending Delete	If there is no Restore Request operation within 30 days, the Redemption Period to Pending Delete batch moves the domain name to Pending Delete state. The Purge Domain on Pending Delete batch purges the domain name from the database after five days, and the domain name is then available for new registrations.

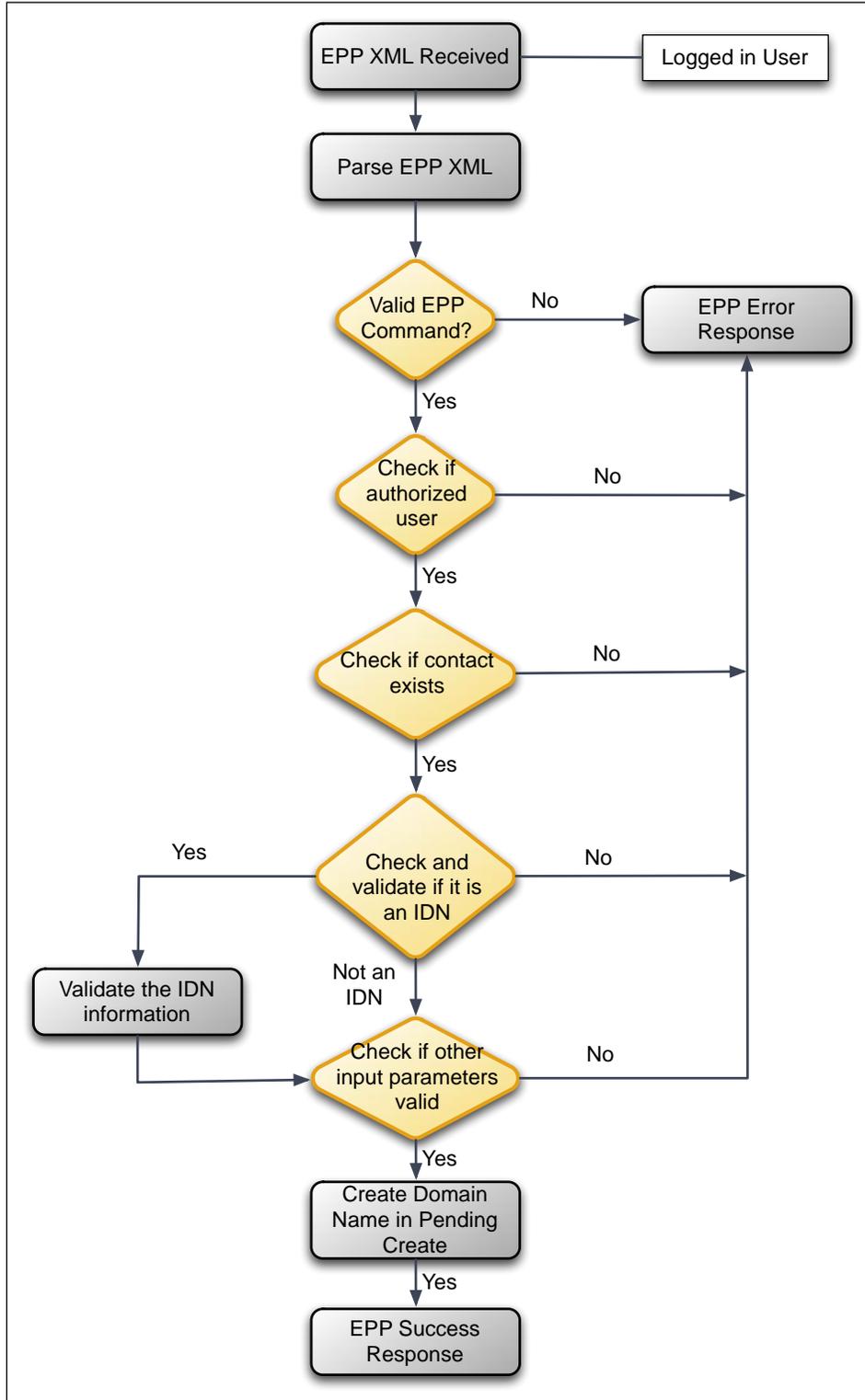


Figure 27-3: Create Process Flow Chart

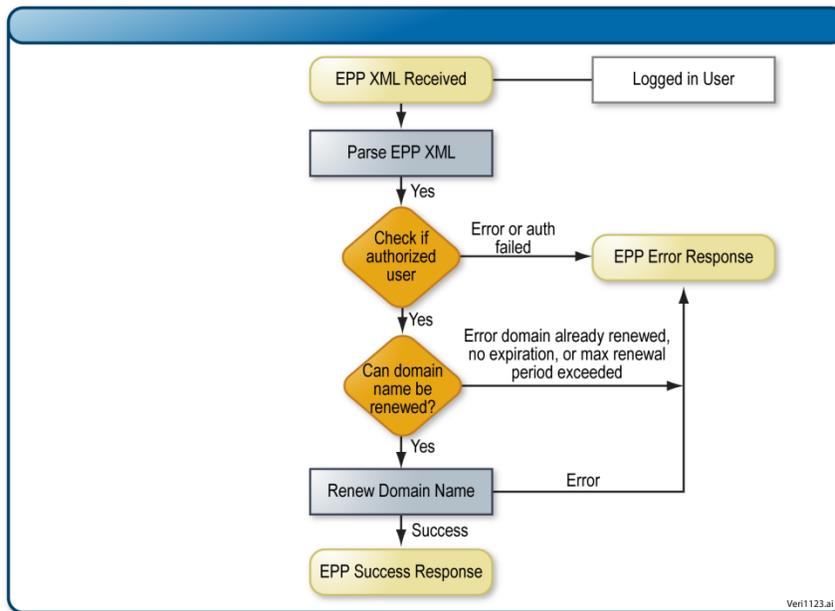


Figure 27-4: Renewal Process Flow Chart

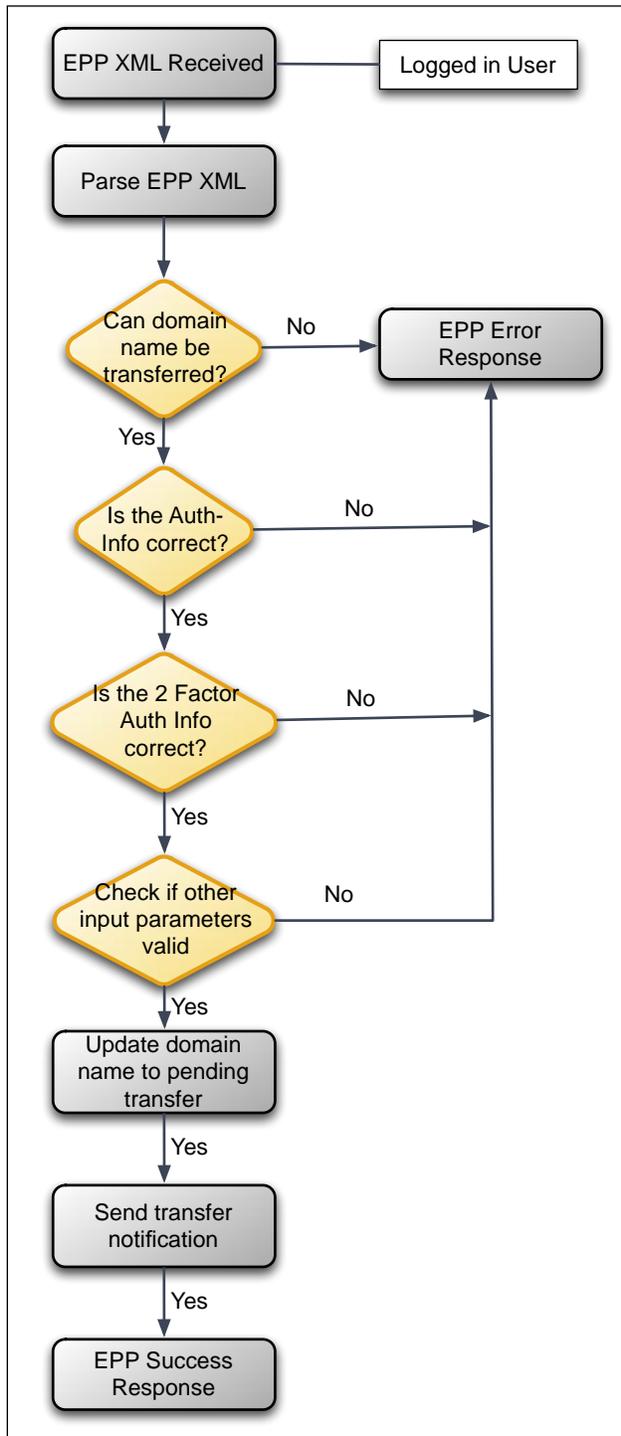


Figure 27-5: Transfer Request Process

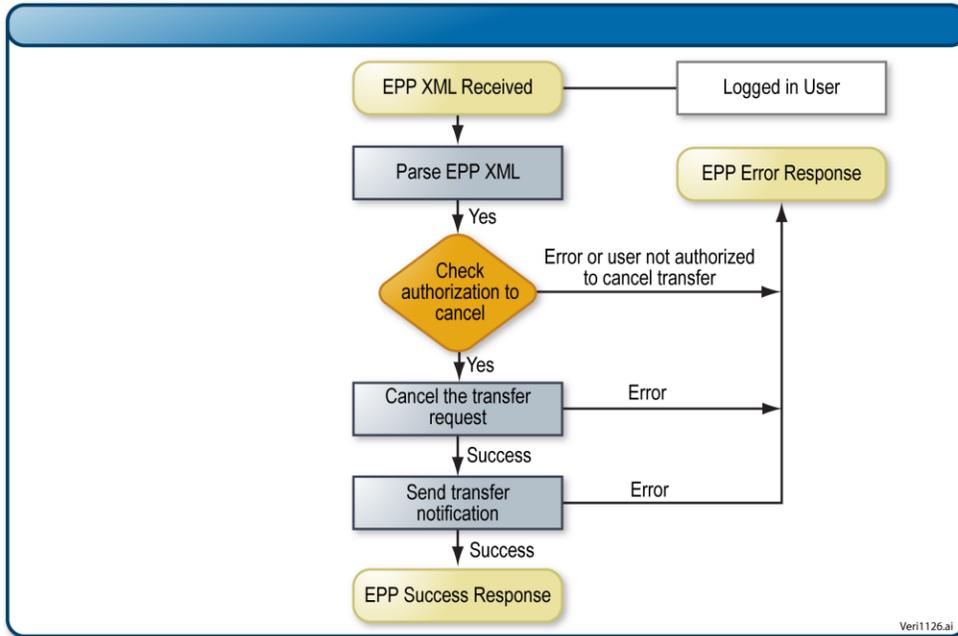


Figure 27-6: Transfer Cancel Process

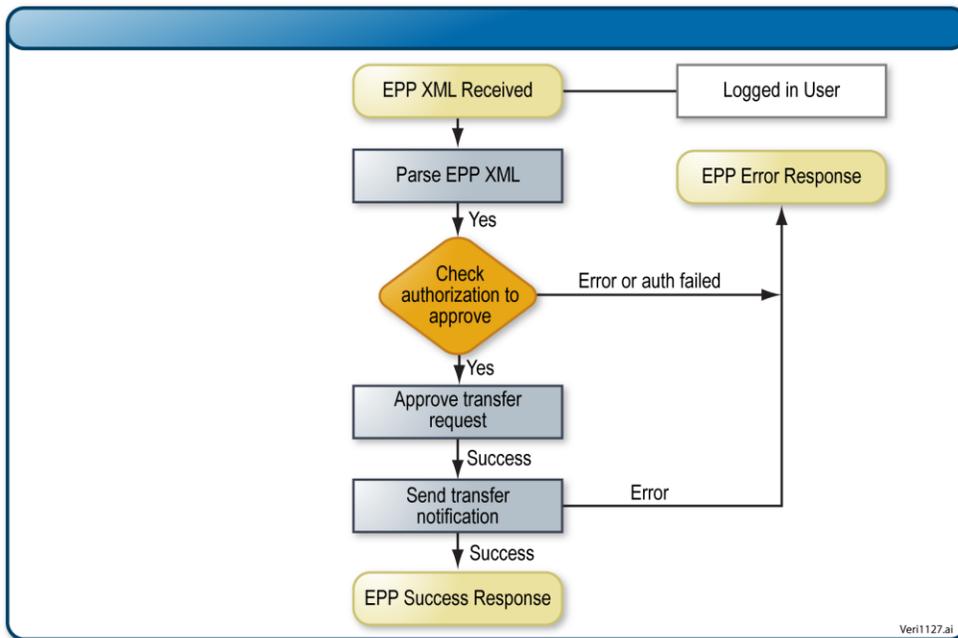


Figure 27-7: Transfer Approve Process

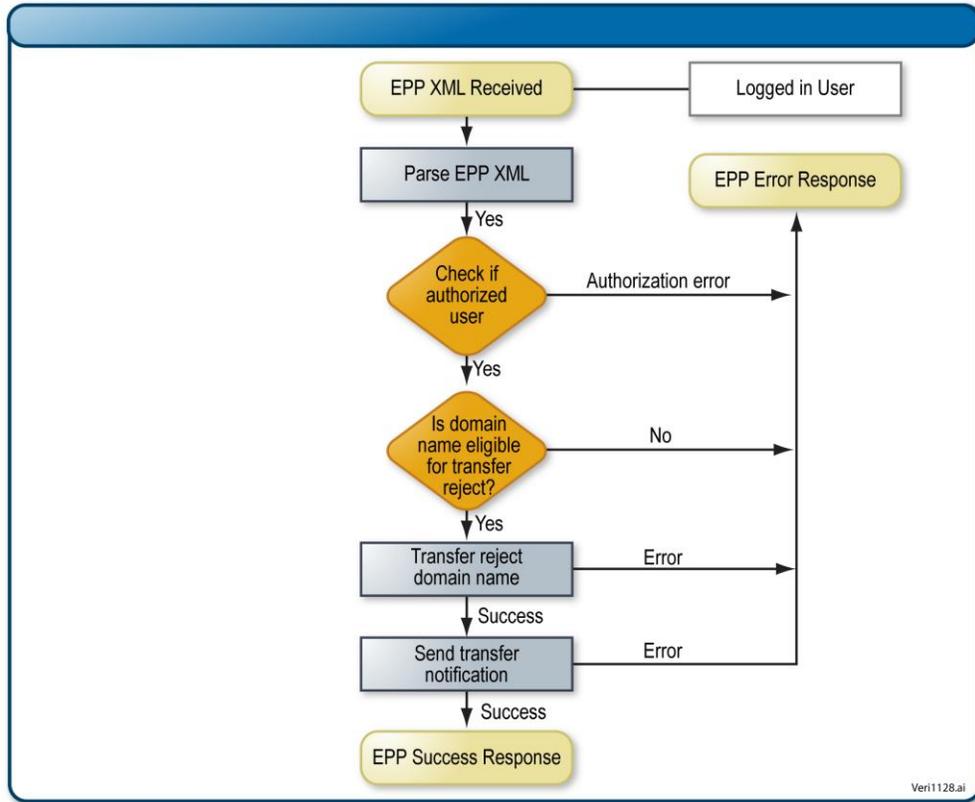


Figure 27-8: Transfer Reject Process

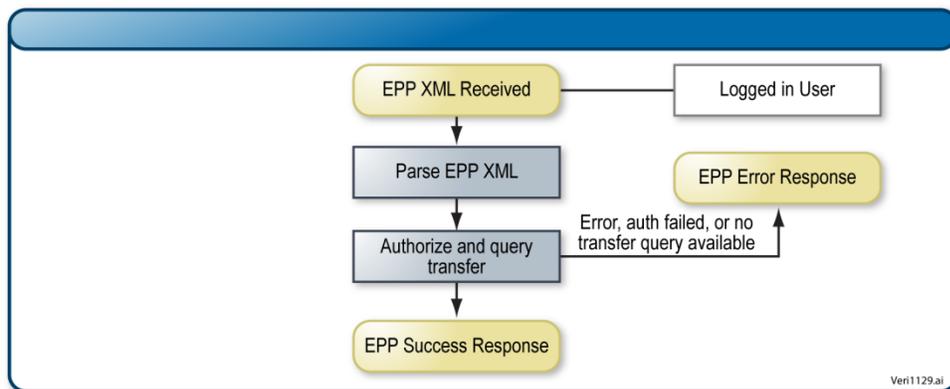


Figure 27-9: Transfer Query Process

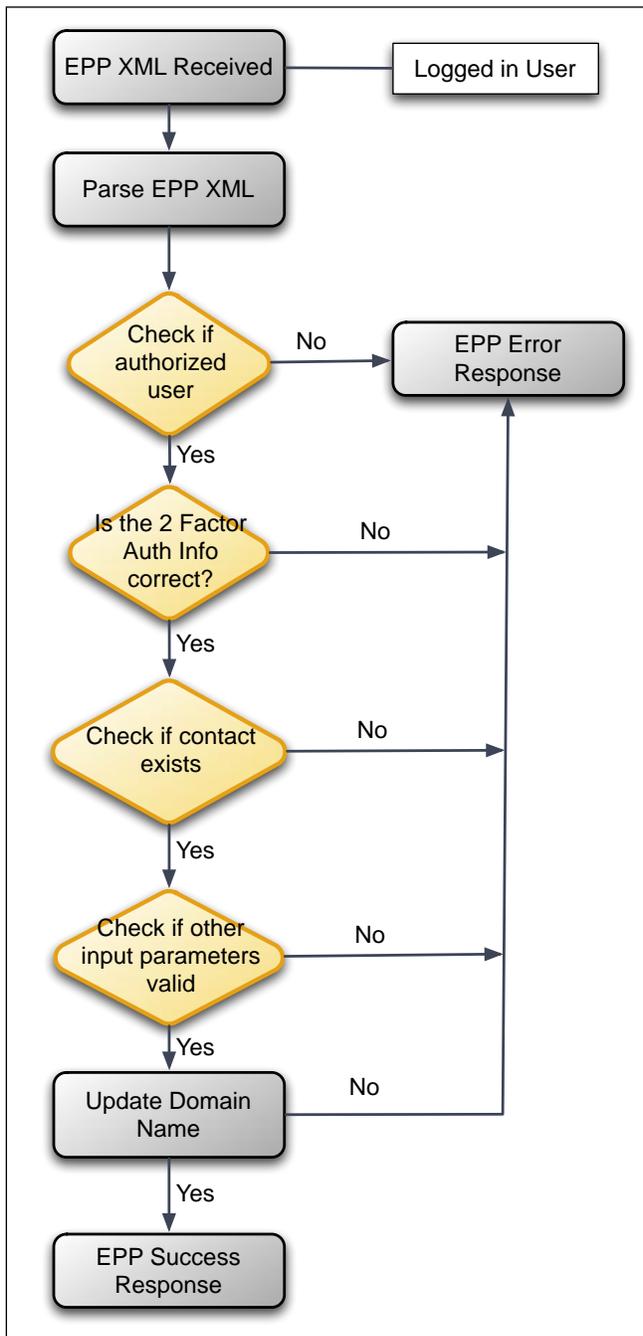


Figure 27-10: Update Process Flow Chart
