I understand from our recent conversation that Dot Registry is applying for the rights to manage new Internet name extensions under ICANN's new GTLD program. I also understand that your applications focus on serving specific communities, which would restrict companies from being awarded a new domain name under your gTLD extensions if they are not determined to be valid and existing U.S. corporations or similar entities. I believe that this requirement would be beneficial to business owners because it will significantly increase their chances of having a domain name that matches their registered name, thereby helping them both promote and protect their online presence. I also believe that having businesses have domain names that match their official company name will help consumers with Internet navigation and will allow them to know they are transacting with a duly established company.

My company, Corporation Service Company (CSC), is an industry leader in both the incorporation of companies in the United States and in serving as a domain registrar of choice for many of owners of the World's most recognized brands. As we discussed, we are interested in exploring a relationship with you where we would leverage our capabilities in both the incorporation and domain space to help you verify that the companies are duly established under the applicable jurisdiction's laws and with issuing the related domain names to other registrars, resellers and registrants.

As the General Manager of the Corporate Identity Protection Division and Head of Global Business Development at CSC, I am acutely aware of the dangers that business identity theft poses to corporations. I also understand that your application is a "members only" community application which restricts a company being awarded a new domain name to be a valid and existing US corporation of similar fidelity. I believe this differentiation in restrictive use will bring a higher level of credibility and trustworthiness to the users and owners of these sites.

I serve as a Chairman of The Roasterie, INC. Our company operates a web site under the domain name <u>theroasterie.com</u>. We are incorporated as a Missouri Corporation and are a member of the larger community of US based corporations.

I am writing in support of Dot Registry's application for the issuance of these "strings'that would attempt to protect legitimate businesses and consumers from confusion or fraud; such restrictions would include measures to authenticate the active and good standing status of all corporations who seek to register a second-level domain within the respective TLD as proposed by DOT Registry.
